Whilst not always required, it is good practice to seek parental approval at the start of the school year for a range of activities or unplanned eventualities that may occur.

Over the course of a typical school year the children are involved in a range of exciting activities that support their learning. Not only do we use our own school grounds, but also like to take them into our local community to complete valuable fieldwork. We also plan lessons, which involve the children preparing, and tasting food.

The children enjoy us recording and celebrating their work through photographs and videos which are used to celebrate their work within school, in our newsletter or in the media. When taking photographs of the children we are very careful not to take or use images which would embarrass children, or show them in unsuitable poses or dress. Full names of children are never released.

Unfortunately during the school year children may also have minor accidents such as bumps and grazes. To avoid unnecessary distress or needing to call parents into school, we also understand the benefits of undertaking first aid on children for minor injuries.
